## **Notification**

[Regarding admission of untrained In-Service Primary Teachers to Two-Year D.El.Ed Course for the Session - 2025-2027 in pursuance of the order of the Hon'ble High Court, Calcutta in WPA No.- 13989 of 2025 (Partha Das & Ors. Vs. The State of West Bengal & Ors.) and WPA No.- 13966 of 2025 (Rajkumar Dogra & Ors. Vs. The State of West Bengal & Ors.) and in adherence to proceedings of meeting held on 25/08/2025 in presence of the Commissioner of School Education, West Bengal and other stakeholders in compliance of solemn order of Hon'ble High Court in above writ petition]

Pursuant to the solemn order dated 14.08.2025 of the Hon'ble High Court, Calcutta passed by the Hon'ble Justice Rajarshi Bharadwaj in WPA No 13989 of 2025 (Partha Das & Ors. Vs. The State of West Bengal & Ors.) and some other similar writ petitions, I have been directed to notify for information to all concerned that,

1. In-service untrained primary school teachers of Malda and North 24 Parganas districts who have recruited pursuant to the recruitment process initiated in the year 2009 and appointed under various orders of the Hon'ble High Court with the Madhyamik or equivalent qualification and teachers having less than 50 percent marks in Higher Secondary or equivalent Examination are allowed to submit their applications for admission to Two-Year D.El.Ed Course for the session 2025-2027 through the online portal of the WBBPE. The aforesaid deviation from the rules of NCTE is made as a special case for the said teachers in view of the solemn order of the Hon'ble High Court, Calcutta. All the interested teachers of the above-mentioned category are instructed to visit our website i.e. <a href="https://wbbpe.wb.gov.in/">https://wbbpe.wb.gov.in/</a>, which will be lived on and from 30th August, 2025. <a href="https://wbbpe.wb.gov.in/">A primary teacher with Madhyamik or Equivalent Qualification, willing to submit application for the aforesaid course, needs to upload the document related to his/her enrolment in HS/equivalent course mandatorily.

Furthermore, the In-Service Primary School Teachers may submit online applications for admission to Two-Year D.El.Ed Course for the Session - 2025-2027 through the Government recognized private self-financed institutions, in addition to Government, Government Sponsored, Government Aided PTTIs and DIETs.

2. The last date for submission of online application for undergoing the aforesaid course will be 8<sup>Th</sup> September, 2025.
